1. What is the Consumers Association Scholarship?

- (a) \$1,500 scholarship to be awarded to a graduating high school senior – year 2010.

2. Who qualifies for the Consumers Association Scholarship?

- (a) Applicant must be a graduating high school senior in year 2010
- (b) Applicant and/or parent/guardian must be a member of Consumers Cooperative Credit Union for a **minimum** of one year.

3. What are the application requirements?

- (a) Completed application – due by December 31, 2009.
- (b) **Official high school transcript through your junior year. A copy of your senior first semester grades, if available.**
- (c) Personal statement
- (d) Photo
1. Attach photo to the application. Please place your name on backside of photo.
 2. Photo is required for publication in newsletter if applicant is a winner.
 3. Photo is non-returnable.
- (e) ***PLEASE NOTE:*** Applicants will be evaluated on academic performance, financial need and leadership abilities (including community involvement).
- (f) If a winner – you must notify the Scholarship Committee of the school you will be attending no later than July 1, 2010.
