Official Rules

Consumers Credit Union (CCU) will giveaway \$2,500.00 cash in our special E-Statements Enrollment Contest! During the promotion, we'll award seventeen (17) cash prizes to Members enrolled in E-Statements at CCU. Here are the details . . .

Promotion Dates: July 1, 2009 - September 30, 2009

Selection Of Winners

1) CCU will award five (5) \$100.00 prizes in July, August and September 2009 for Members who enroll for E-Statements and/or accept the online disclosure from July 1, through September 30 (15 \$100.00 winners total during the three month period). ***Eligibility to win is cumulative, meaning those who enroll and/or accept the disclosure in July will be included in the drawings for all three months; those who enroll and/or accept the disclosure in August will be included in the drawings for August and September; and, those who enroll and/or accept the disclosure in September will be included in the drawings for September.*** CCU will select the winners at random from all eligible Members, based on the criteria listed in this section.

2) Two (2) \$500.00 Grand Prizes will be awarded at the end of the contest: one (1) for Members who enroll for E-Statements and/or accept the online disclosure from July 1, through September 30, 2009; and, one (1) for Members who enrolled for E-Statements and have accepted the online disclosure prior to July 1, 2009. CCU will select the winners at random from all eligible Members, based on the criteria listed in this section.

How To Enroll For E-Statements

There are three (3) ways to enroll in E-Statements: self-enroll using Online Banking; calling 877 275.2228; or, in person at any of CCU's six (6) locations, as follows;

- **Self-enrollment** (must already use Online Banking): log onto Online Banking from Home Page of CCU's website; select the e-Statements tab above Account Summary; select "Continue" when on the message advising you you're leaving the CCU site; read and "**ACCEPT**" the conditions in the disclosure; and, enter an e-mail address where you want to receive notifications as e-statements are available for viewing.
- **Enrollment by calling or going to a Branch Office** (NOTE: if you have not yet enrolled in Online Banking, you will need to do so first): call 877.275.2228 or stop by any office (in lobby or drive through); provide your enrollment information, including a current e-mail address; log onto Online Banking, then follow the steps listed in the preceding section, including reading and selecting "**ACCEPT**" regarding the conditions in the disclosure. ***NOTE: you are not eligible to win any prizes until you accept the online disclosure.***

You must be a current CCU Member with your account in good standing at the time your name is drawn to win any of the prizes for which you are otherwise eligible. Limit one (1) \$100.00 prize per Member during this promotion; all \$100.00 winners are eligible to win the \$500.00 Grand Prize for Members who enroll for E-Statements and/or accept the online disclosure from July 1, through September 30, 2009.
