2019 OFFICIAL RULES

SPONSOR AND ADMINISTRATOR

The Drawing (the "**Drawing**") is sponsored and administered by Consumers Cooperative Credit Union ("CCCU"), 1075 Tri State Pkwy, Ste 850, Gurnee, IL 60031.

AGREEMENT TO THE OFFICIAL RULES

By participating in the Drawing, all players fully and unconditionally agree to and accept these Official Rules and the decisions of CCCU as final and binding in all matters related to the Drawing. Winning a prize in the drawing is contingent upon fulfilling all requirements set forth herein.

PROMOTION PERIOD

The Drawing starts on March 1, 2019 at 9:00AM Central Daylight Time ("CDT") and ends on April 30, 2018 at 6:00PM CDT (the "Drawing Entry Period"). CCCU is the official timekeeper for the Drawing.

ELIGIBILITY

Entry is open to Members of CCU; must be 18 years or older to enter. Limit one (1) entry per person, per household and per email address for the entire Promotion Period.

Employees and officials of CCCU, LK-CS and CCU Realty Services and their immediate families (parent, child, sibling or spouse) and/or persons living in their household, and any other persons or entities associated with the Drawing ("Official Family") are not eligible to enter or claim a prize.

HOW TO ENTER

Eligible participants may enter the Drawing by

Entries must be received during the Drawing Entry Period. Late entries will not be eligible for the Drawing Prize. All entries shall be subject to verification by CCCU.

It is the sole responsibility of the entrant to notify CCCU in writing if the entrant changes his or her email address during the Drawing Entry Period.

Any attempt by any person to obtain more than one entry by using multiple/different email addresses, names, identities, or any other methods will void that persons entries and the person will be disqualified from winning.
